

**ORDINANCE No. 13/2024**  
**of the Rector of the University of Wrocław**  
**of 31 January 2024**

**on the fees for educational services provided at the University of Wrocław for  
the teaching cycles commencing in the academic year 2024/2025**

Pursuant to Article 23, section 1 and Article 79, section 1 of the Act of 20 July 2018. Law on Higher Education and Science (Journal of Laws of 2023, item 742, as amended), it is ordered as follows:

§ 1. This ordinance sets the fees for the following educational services:

- 1/ the education of **Polish citizens and foreigners** in part-time studies and part-time doctoral studies conducted in the Polish language;
- 2/ repetition of classes due to unsatisfactory academic performance and for participation in classes not included in the curriculum of full-time and part-time studies as well as full-time and part-time doctoral studies conducted in the Polish language for **Polish citizens and foreigners**;
- 3/** education of **foreigners** in full-time studies conducted in the Polish language;
- 4/ repetition of classes due to unsatisfactory academic performance and for participation in classes not included in the curriculum of full-time and part-time studies as well as full-time and part-time doctoral studies conducted in the Polish language for **Polish citizens and foreigners**;

§ 2.1. The amount of tuition fees for Polish citizens and foreigners in part-time studies and part-time doctoral studies conducted in the Polish language shall be determined by:

- 1/ Appendix **No. 1** at the Faculty of Letters;
- 2/ Appendix **No. 2** at the Faculty of Historical and Pedagogical Sciences;
- 3/ Appendix **No. 3** at the Faculty of Social Sciences;
- 4/ Appendix **No. 4** at the Faculty of Law, Administration and Economics.

2. The amount of tuition fees for Polish citizens and foreigners in part-time studies and part-time doctoral studies conducted in the Polish language for:

- repetition of classes due to unsatisfactory academic performance,
- implementation of courses not included in the curriculum (not applicable to full-time and part-time doctoral studies),
- established programme differences in the case of reactivation, change of the form of study, transfer from another higher education institution or transfer from another field of study /specialistaion (**applies only to part-time studies**),

is specified in Appendix **No. 5** to this ordinance.

3. The amount of fees related to education of foreigners at full-time studies conducted in the Polish language is specified in Appendix **No. 6** to this ordinance.

4. The amount of fees related to tuition, repetition of courses due to unsatisfactory academic performance, for determined programme differences in the case of reactivation, change of the form of studies or transfer from another higher education institution or transfer from another field of study/major specialisation as well as for participation in classes not included in the curriculum of full-time and part-time studies conducted in English is specified in Appendix **No. 7** to this ordinance.

§ 3. Fees for full-time education of foreigners in the Polish language, as specified in Appendix **No. 6**, are not charged to:

- 1/ nationals of a Member State of the European Union, the Swiss Confederation or a Member State of the European Free Trade Association (EFTA) - a Party to the Agreement on the European Economic Area and members of their families residing in the territory of the Republic of Poland;
- 2/ a citizen of the United Kingdom of Great Britain and Northern Ireland referred to in Article 10(1)(b) or (d) of the Agreement on the withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union and the European Atomic Energy Community (Official Journal of the European Union L 29 of 31.01.2020, p. 7, as amended) and members of their families residing in the territory of the Republic of Poland;
- 3/ persons in possession of a valid Polish Citizen's Card or persons who have been issued a decision (not an opinion) on a recognition of Polish origin;
- 4/ persons who have been granted a permanent residence permit (holders of a permanent residence card);
- 5/ persons who have been granted a residence permit of a long-term resident of the European Union;
- 6/ persons who have been granted a temporary residence permit in connection with the circumstances referred to in Article 159(1) or Article 186(1)(3) or (4) of the Act on Foreigners of 12 December 2013 (this specific provision must be indicated on the decision on granting the permit)
- 7/ persons having the status of refugee granted in the Republic of Poland or enjoying temporary or subsidiary protection in the territory of the Republic of Poland (holders of a residence card with the annotation "refugee" or a decision on its granting);
- 8/ persons who hold a certificate attesting the knowledge of Polish as a foreign language at least at the C1 language proficiency level. The only authorising document is a certificate issued by the State Commission for the Certification of Proficiency in Polish as a Foreign Language;
- 9/ persons who are the spouse, ascendant or descendant (child, grandchild) of a citizen of the Republic of Poland, residing on the territory of Poland;
- 10/ persons who have been granted a temporary residence permit for the purpose of scientific research (Article 151(1) of the Act on Foreigners of 12 December 2013 - this specific provision must be indicated on the decision on granting the permit);
- 11/ persons who have been granted a temporary residence permit for the purpose of long-term mobility of a researcher (Article 151b(1) of the Act of 12 December 2013 on foreigners - this specific provision must be indicated on the decision on granting the permit);
- 12/ persons staying on the territory of the Republic of Poland in connection with the use of short-term mobility of a researcher under the conditions set out in Article 156b(1) of the Act of 12 December 2013 on foreigners - this specific provision must be indicated on the decision on granting the permit;
- 13/ persons holding a national visa to carry out scientific research or development work.

§ 4. The amount of the semester fees for basic physical education classes and the didactic offer including outdoor and weekend classes and sports and recreational camps, fully paid by the student, implemented as part of the physical education credit, is specified in Appendix **No. 8** to this Ordinance.

§ 5. Supervision of the implementation of this ordinance is entrusted to the Vice-Rector for Teaching.

§ 6. The ordinance shall enter into force on the date of its signature.

2) The fee applies to additional teaching hours beyond the free-of-charge limit of 60 hours to which full-time students are entitled pursuant to § 9 of the Ordinance No. 42/2020 of the Rector of the University of Wrocław of 3 April 2020 introducing the Principles of Teaching Modern Foreign Languages and accounting for students in language courses at the Foreign Languages Centre at the University of Wrocław.

The amount of the fee for the repetition of continuous teaching practice, according to the dimension specified in the plan, is **PLN 290** per week of practice.

- I. The fee for one semester is half of the annual fee.
- II. Polish citizens can pay fees in PLN.
- III. Foreigners, from the second year of study onwards, may pay fees in PLN.
- IV. The fee for repeating a course due to unsatisfactory performance is **EUR 5** or the equivalent in PLN per hour of tuition. The sum of fees for repeating classes in a given accounting period cannot exceed the tuition fee for that period.
- V. The fee for participation in classes not included in the curriculum (applies only to classes at the Foreign Languages Center and the School of Polish Language and Culture for Foreigners) is **EUR 5** or the equivalent in PLN per hour of tuition.
- VI. The fee for determined programme differences in the case of reactivation, change of the form of study or transfer from another university is **EUR 5** or the equivalent in PLN per hour of study.

The amount of the fee in PLN is established according to the average PLN/EUR exchange rate, as **announced in the announcement of the President of the Public Procurement Office** of 3 December 2023 on the current EU thresholds, their equivalents

in PLN, the PLN equivalent of the amounts expressed in EUR and the average PLN/EUR exchange rate constituting the basis for converting the value of public contracts or competitions - in the year of payment (information on the PLN/EUR exchange rate can also be found on the BIP website of the University of <https://bip.uni.wroc.pl/516/288/sredni-kurs.html>).
